

Application for representatives who engage primarily in the supervision of trainees

Important

A representative who acts as a supervisor may have five trainees under his responsibility at any time.

However, a representative who engages primarily in the supervision of trainees may, if he is designated as such by the employer, have up to 10 trainees under his responsibility at any time.

The representative who engages primarily in the supervision of trainees must meet the eligibility requirements to become a supervisor, including ensuring that they have the time, qualities, and skills necessary to adequately mentor an intern. He must fulfill the same duties and responsibilities as a regular supervisor.
