Excellence Scholarships and Internships !

The purpose of the Education and Good Governance Fund's (EGGF's) Excellence Scholarship Program is to increase knowledge in all areas associated with the AMF's mission and visibility. It is intended for Québec university students at the Master's and Doctoral levels. The EGGF will earmark up to \$100,000 per year for this program, which is aimed particularly at students in the fields of finance, insurance, law, criminology, administration, governance, economics, ethics, accounting, education, consumption and securities.

Candidates are selected by the AMF's President and CEO upon the recommendation of the EGGF's Assessment Committee of five independent outside experts. Recipients receive their scholarships once a year at the Rendez-vous with the AMF event attended by the President and CEO.

AMF scholarships and internships

Doctoral and Master's scholarship recipients receive \$10,000 and \$5,000 respectively and undertake a six-week paid internship at the AMF. The following criteria are used in the evaluation process:

- Academic excellence (60%)
- Engagement in the field (10%)
- Research potential (10%)
- Passion for their chosen field (10%)
- Overall assessment of the application (10%)
