Regulation to amend Regulation 81-106 respecting Investment Fund Continuous Disclosure and concordant regulations - Modernization of the Continuous Disclosure Regime for Investment Funds

Notice is hereby given by the *Autorité des marchés financiers* (the "Authority") that, in accordance with section 331.2 of the *Securities Act*, chapter V-1.1, the following Regulations, the text of which is published hereunder, may be made by the Authority and subsequently submitted to the Minister of Finance for approval, with or without amendment, after 120 days have elapsed since their publication in the Bulletin of the Authority:
