

**REGULATION TO AMEND REGULATION 81-107 RESPECTING INDEPENDENT REVIEW COMMITTEE FOR INVESTMENT FUNDS\***

Securities Act  
(R.S.Q. c. V-1.1, s. 331.1, pars. (17) and (34); 2008, c. 24; s. 225, 2009, c. 25, s. 45)

**1.** Section 6.2 of Regulation 81-107 respecting Independent Review Committee for Investment Funds is amended:

(1) in the French text of paragraph (1):

(a) by replacing, in the introductory phrase, the words “à la société de gestion qui en assure la gestion ou à une entité apparentée à la société de gestion” with the words “à son gestionnaire ou à une entité apparentée au gestionnaire”;

(b) by replacing, in subparagraph (b), the words “la société de gestion qui assure la gestion du fonds d’investissement” with the words “son gestionnaire”;

(2) by deleting paragraph (4).

**2.** Appendix A of the Regulation is amended:

(1) by adding, in the column “**JURISDICTION**”, after “New Brunswick”, “Northwest Territories”;

(2) by adding, in the column “**SECURITIES LEGISLATION REFERENCE**”, opposite “Northwest Territories”, “Part 11 – Insider Reporting and Early Warning of the Securities Act (Northwest Territories)”;

(3) by adding, after the words “Part 4 of Regulation 81-102 respecting Mutual Funds”, the words “and section 13.5 of Regulation 31-103 respecting Registration Requirements and Exemptions approved by Ministerial Order no. 2009-04 dated September 9, 2009”.

**3.** Appendix B of the Regulation is replaced with the following :

**4.** The Regulation is amended:

(1) by deleting, wherever they appear, the words “or company”;

(2) by replacing, wherever they appear in the French text, the words “membre de la direction” and “membres de la direction” with the words “dirigeant” and “dirigeants” and the words “société de gestion”, “la société de gestion”, “à la société de gestion”, “de la société de gestion”, “la nouvelle société de gestion” and “la même société de gestion” with the words “gestionnaire”, “le gestionnaire”, “au gestionnaire”, “du gestionnaire”, “le nouveau gestionnaire” and “le même gestionnaire”, respectively, and making the necessary changes.

**5.** This Regulation comes into force on September 28, 2009.
