The *Autorité des marchés financiers* may refuse to recognize as common shares any shares which, while complying with a literal application of the definition, do not guarantee their holder the full rights ordinarily attached to such shares, because of the conditions governing them or the rights conferred on some other class of shares.

In particular, it may refuse to recognize as common shares any shares whose issue has been preceded, or may be followed by the issue of shares conferring voting rights for consideration substantially lower per voting right.
